#### PRODUCTSPECIFICATION

The products mentioned below belong to this certificate:

Jahn M30 injection glue; Jahn M40 injection mortar; Jahn M50 injection mortar; Jahn M60 plaster mortar, types A, B, C & D; Jahn M70 natural stone restoration mortar, codes 0010, 0011, 0012 and 0016; Jahn stamp mortar, code 0018; Jahn M70 natural restoration mortar, codes 0021, 0022, 0023, 0024 and 0026; Jahn M90 concrete repair mortar; Jahn M100 brick-/terracotta repair mortar, code 0024; Jahn M110 pointing mortar, codes 0012, 0016, 0022, 0023 and 0024; Jahn M120 spatula material.

## APPROVAL

The products are approved on the basis of the requirements set in the "Regeling materialen en chemicaliën leidingwatervoorziening" ("Regulation Materials and Chemicals for Drinking Water Supplies"; published in the Staatscourant).

The migration has to be measured according to the standardised CGCMD-migration-test (see 'Guideline quality of materials and chemicals for drinking water supplies', publication 94-01 by the Inspectorate of Public Housing and the Environment).

- arsenic  $< 0.5 \text{ mg/dm}^2$ - cadmium  $< 0.05 \text{ mg/dm}^2$ 

- chromium < 0,5 mg/dm<sup>2</sup>

- mercury  $< 0.01 \text{ mg/dm}^2$ 

- lead < 0,5 mg/dm<sup>2</sup>
